How does it work?

Establishing your own fund at The County Foundation

Giving to an existing fund at The County Foundation

Whatever option you choose, you can rest assured that your donation is invested wisely, and the proceeds are distributed according to your direction.



Establishing your own fund at The County Foundation

The detailed instructions for your fund can be outlined in a **Memorandum of Understanding (MOU)** with The County Foundation or included directly in your Will. The County Foundation must be included in your Will and establishing your own fund requires a minimum of \$25,000.

The MOU is not legally binding but establishes the directions and goals you have for the fund. We have a number of different types of funds and you can easily update your MOU at any time.

We can walk you through this process from the beginning and ensure your giving has the greatest impact possible in the community.
