

The purpose of the Built Heritage Fund Grants is to offer a specified amount of funding which will aid the preservation, protection, or restoration of a heritage* structure within the geographic area of Prince Edward County deemed historically or culturally significant to the community. **Applications due Monday April 20th at 4pm.**

*Heritage” does not necessarily imply official designation.

ELIGIBILITY	HOW TO APPLY
<p>Grant Size: Up to 20,000</p> <p>Eligibility of Project: 1) Project must be within the Municipality of Prince Edward County; 2) The project must meet a “bricks and mortar” definition; 3) The project must have a well-defined purpose related to the preservation of the structure and it must take place within one year of receiving the grant.</p> <p>Grants will not be awarded for regular maintenance, ongoing operating costs, administration fees, salaries, deficits, debt reduction, and the like.</p> <p>Eligibility for Grant Recipients: Applicant must be a Qualified Donee as defined by the Income Tax Act, or be working in collaboration with a Qualified Donee.</p>	<p>You can submit the application form to The County Foundation in the following ways:</p> <ul style="list-style-type: none"> • Scan and email to info@thecountyfoundation.ca • Mail to: The County Foundation - 35 Bridge St, Suite 107, PO Box 24, Picton, ON, K0K 2T0 <p>Reports: All grant recipients will be required to complete a Final Report to you evaluate the project and for us to help evaluate the impact of the grants.</p> <p>Recognition: If your application is successful, you agree to hosting a sign on the project property for a limited time acknowledging the grant from the Built Heritage Fund.</p>


